### PACKING AND REMOVALS GUIDE

### PACKING AND REMOVALS

#### 1. When to Start Looking for a Removals Company

- Start Early: Look for a removals company 4-6 weeks before your move.
- Why Early?: Book early to secure your date, compare prices, and accommodate special needs.
- Valuables: Removals companies often don't cover valuables (jewelry, cash). Arrange secure transport for these yourself.
- Heavy/Bulky Items: Notify the company about heavy or large items to avoid delays on moving day.
- Key Collection: Confirm when you can collect keys and inform the removals company to coordinate timing.
- 2. Packing Guide
  - Start Early: Begin packing well in advance to stay organized.
  - Declutter First: Decide what to keep, donate, or discard before packing.
  - Gather Supplies: Sturdy boxes, tape, bubble wrap, and markers are essential.
  - Pack Room by Room: Label boxes with contents and destination rooms.
  - Essentials Box: Pack essentials like toiletries and important documents separately.
  - Packing Techniques:
    - Heavy items in small boxes; light items in large boxes.
    - Wrap fragile items and mark boxes as "FRAGILE."
  - Special Items:
    - Electronics: Use original packaging if possible.
    - Artwork/Mirrors: Wrap and transport upright.
    - Furniture: Disassemble and label small parts.

### MOVING WITH PETS

#### 3. Transporting Pets

- Plan Ahead: Update pet microchip and tags with your new address.
- Vet Visit: Schedule a check-up and ask for moving advice.
- Acclimate Pets: Get pets used to their carrier weeks before the move.
- On Moving Day:
  - Keep pets in a quiet room or with a friend.
  - For car travel, secure the carrier and take breaks.
  - For air travel, check airline pet policies and prepare the carrier accordingly.
- Settling In:
  - Introduce pets gradually to the new home.
  - Maintain their routine for comfort.
  - Surround pets with familiar items like their bed and toys.

## WHO TO NOTIFY OF YOUR MOVE

We recommend setting up a royal mail redirection service for the first 3-6 months to allow for if you miss any suppliers or services

#### 3. Government and Official Bodies

- DVLA (Driver and Vehicle Licensing Agency): Update your driving license and vehicle registration.
- HMRC (Her Majesty's Revenue and Customs): Notify for tax purposes.
- Electoral Register: Update your address for voting purposes.
- Local Council: For council tax and any local services.
- Department for Work and Pensions (DWP): If you receive any benefits or state pension.
- Passport Office (if you wish to update your address on your passport).

#### 4. Subscriptions and Memberships

- Gym or Fitness Club
- Magazine or Newspaper Subscriptions
- Online Services (e.g., Netflix, Amazon Prime)
- Professional Associations or Unions
- Charity Donations or Memberships

## GETTING SETTLED IN

#### 1. Explore Your New Area

- Walk or Drive Around: Take a few days to explore your new neighborhood.
- Find Local Essentials: Locate the nearest grocery stores, pharmacies, petrol stations, and other essential services.

2. Meet Your Neighbours

- Introduce Yourself: A simple knock on the door to introduce yourself can go a long way in building good relationships with your neighbors.
- Attend Local Events: Community events like fairs, markets, or neighborhood gatherings are great opportunities to meet people.
- Join Local Groups: Many areas have community groups, whether it's for gardening, book clubs, or sports teams. Check notice boards in local shops or community centers.
- 3. Discover Local Events and Activities
  - Websites to Use:
    - Eventbrite: Find local events, workshops, and social gatherings.
    - <u>Meetup</u>: Join groups of people with similar interests and discover local events.
    - Facebook Local: Check out events happening nearby through Facebook.
    - <u>Time Out</u>: Explore recommendations for restaurants, bars, and things to do in major UK cities.
    - DogFriendly: Find dog-friendly walks, parks, and pubs in your area.
- 4. Explore Dog Walks and Outdoor Activities
  - Plan Your Walks: Use apps like <u>AllTrails</u> or <u>Komoot</u> to find popular walking routes, hiking trails, and nature reserves nearby.

5. Get to Know Your Bin Day and Local Services

- Check with Your Local Council: Visit your council's website to find out your bin collection day, recycling schedules, and any other local services.
- Sign Up for Alerts: Many councils offer email or text alerts for bin collection reminders or other local updates.
- 6. Settle into Your Home
- Unpack Essentials First: Start with the most important rooms like the kitchen, bathroom, and bedroom to make your home functional quickly.
- Plan a Housewarming: Invite friends or new neighbors over for a small gathering to make your new space feel more lived-in.
- 7. Stay Informed About Your Community
  - Subscribe to Local News: Sign up for newsletters or follow social media pages for local news, events, and updates.
  - Get Involved: Volunteer for community projects or join the neighborhood watch. It's a great way to contribute and get to know your area better.

## TENANCY BASICS

- 1. Reporting Maintenance Effectively
  - Report Promptly: Notify your landlord or property manager as soon as you notice a maintenance issue. Delays can worsen problems and lead to higher repair costs.
  - Provide Details: When reporting an issue, be specific about the problem and its location. Include photos if possible to help the landlord or agent assess the situation.
  - Use the Correct Channels: Report issues according to your tenancy agreement, whether it's through an online portal, email, or phone.

#### 2. Tenant Responsibilities

- Pay Rent on Time: Ensure rent is paid by the due date specified in your tenancy agreement. Late payments can result in penalties or legal action.
- Keep the Property Clean: Maintain cleanliness and take care of the property. Regularly clean and perform minor tasks to prevent damage.
- Report Issues: Inform the landlord or property manager of any maintenance issues or repairs needed.
- Respect Neighbors: Follow local noise regulations and be considerate of your neighbors.
- Ensure Safety: Check smoke detectors, carbon monoxide detectors, and any other safety equipment to ensure they are functional.
- Follow the Terms: Abide by the terms set out in your tenancy agreement, including any restrictions on alterations or subletting.
